

# WHAT IS MEANT BY DECOMMISSIONING AND RESTORATION?

- "Decommissioning" refers to the process of dismantling a renewable energy project and removing the project infrastructure following the end of its useful life.
- •"Restoration" means returning the land to an acceptable state following project construction or a project's useful life. A baseline restoration should reasonably require returning the land to its pre-construction or pre-project state. Specific restoration requirements may be in place (e.g., via land control agreement, state law, ordinance, etc.).

- State Laws or Regulations
- County or Local Ordinances
- Decommissioning Agreements
- Site Control Agreements (e.g., Solar or Wind Leases)

#### STATE LAWS OR REGULATIONS

- Some states may treat Wind and Solar separately (e.g., OK, TX, WI).
- •Texas law require certain provisions to be included in the land control agreements
- •Illinois law requires project owner to enter into Agricultural Impact Mitigation Agreement (AIMA) with IL Department of Agriculture as part of permitting process.
- •Other states regulate via administrative law (e.g., NY Office of Renewable Energy Siting (ORES) and Wisconsin Public Service Commission)

## COUNTY ORDINANCE/LOCAL REGULATION

- Most regulation occurs at local level
- Ordinance may include specific decommissioning/restoration requirements and/or require submission of a decommissioning plan from project owner
- Decommissioning plan may be necessary condition to getting project permitted
