The “Green” Problem: Balancing ESG Pressures

Banks Retreating

BNP Paribas... will no longer provide any financing dedicated to the development of new oil and gas fields... as it reiterated its target of an 80% cut of its oil exploration financing by 2030...

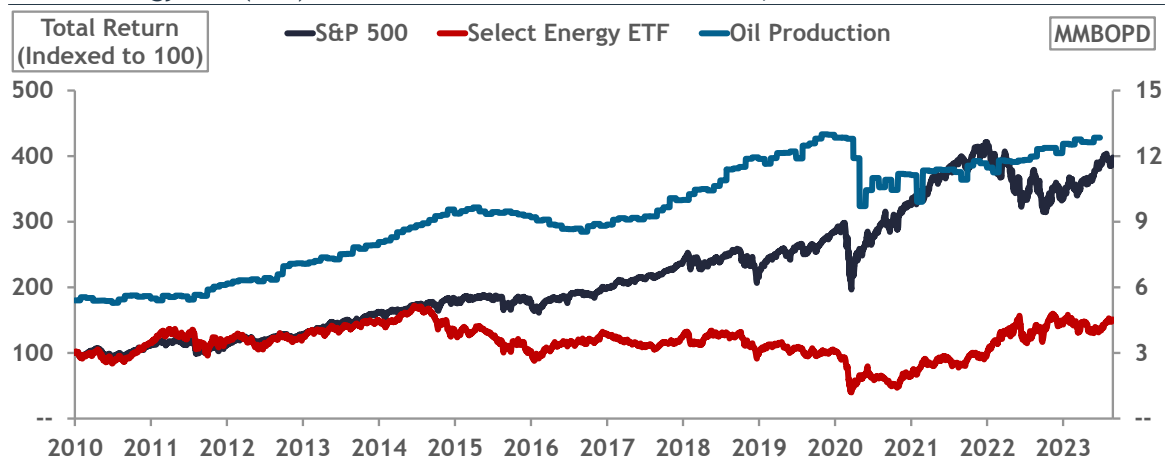

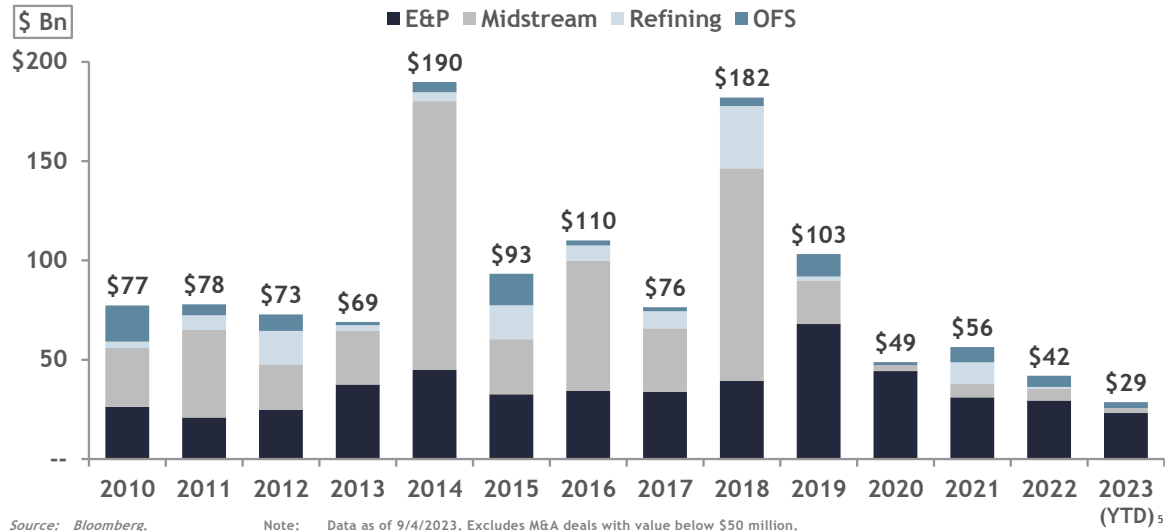

The Decline of M&A “Exits”

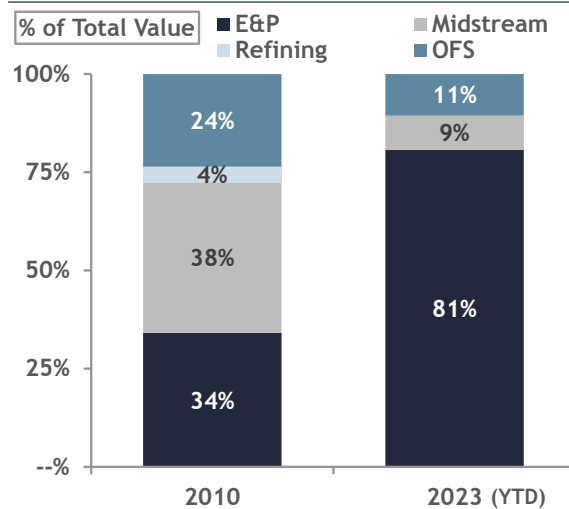
U.S. Energy M&A Volumes by Sector, 2010-YTD 2023



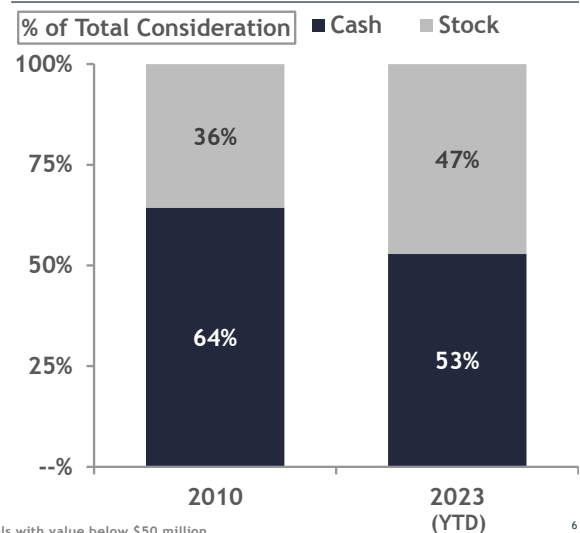
