

- B. General Health Care Laws Affecting Transactions:
  - Anti Kickback Statute (and state equivalents); 42 U.S.C. § 1320a-7b(b); Tex. Occ. Code § 102.001 et seq.
  - Stark Law (and state equivalents); 42 U.S.C. § 1395nn
  - False Claims Act (and state equivalents)
  - HIPAA (and state privacy rules)
  - State and Federal Permits and Licensing
  - Medicare/Medicaid Program Requirements (including overpayment rules)
  - Billing/Collection/Reimbursement
  - Antitrust: FTC/HSR
  - Tax and Tax Exemption Laws and Issues

## NOW THE WORK BEGINS: DUE DILIGENCE

- C. Physician Relationships
  - Very important due to potential liability exposure; not as immaterial as they used to be
  - Independent Contractor
  - Leasing
  - Employment
  - Medical Directorships/Call Coverage Arrangements
  - Compliance/Coding Audits
  - Identified Overpayments
  - Cost Report Analysis (Rural Health Clinics)
  - Ethics Rules 1.06, 1.07, and 1.09 (Conflict of Interest: Former Client)
