Standards of Review for PTAB Appeals

- Questions of law are reviewed *de novo*.
 - Claim construction
 - Statutory interpretation
 - Compliance with obviousness legal standards under § 103
 - Whether a claim invokes means-plus-function under § 112 ¶ 6
 - Function and corresponding structure determinations under § 112 ¶ 6
 - Patentable subject matter under § 101
 - Constitutional questions

Standards of Review for PTAB Appeals

- Questions of fact are reviewed for **substantial evidence**.
 - Anticipation under § 102
 - Underlying obviousness factual issues under § 103
 - Analogous art
 - Scope and content of the prior art
 - Reasons to combine
 - Secondary considerations
- Compliance with procedural/evidentiary rules reviewed for **abuse of discretion**.

Belt & Suspenders Approach to Evidence

- Alternative evidence can support your positions if your primary evidence is not available.
 - Strongest evidence may get excluded, or accorded little weight.
 - Make sure your alternative evidence is cited in papers (not just in declaratory evidence).
 - Example: include evidence on how the claim is met under both parties' proposed claim construction.
 - Attorney argument need not be rebutted with expert testimony (*Idemitsu*), but it certainly doesn't hurt.

Belt & Suspenders Approach to Theories

- Alternative theories (e.g., reasons to combine) can lead the CAFC to rule in your favor even if your primary argument fails.
 - Preserve alternative theories in your Reply or Patent Owner Response. Do not waive if possible.
 - Arguments not meaningfully developed are treated by the CAFC as waived, and you could lose a partial win (*HTC Corp.*)
 - Harmless error can be your savior.
