## THE INTEREST CONVEYED BY AN OIL AND GAS LEASE

- An oil and gas lease creates a fee simple determinable estate, by making the conveyance of the mineral estate subject to a special limitation
  - A conveys Blackacre to B "for so long as" B shall use Blackacre for a particular purpose
    - B receives defeasible estate in the minerals
    - A retains a possibility of reverter

#### **Requirements for Conveyance**

#### Tex. Prop. Code § 5.021

"A conveyance of an estate of inheritance, a freehold, or an estate for more than one year, in land and tenements, must be in <u>writing</u> and must be <u>subscribed</u> and <u>delivered</u> by the conveyor or by the conveyor's agent authorized in writing."



#### Consideration

(Payment of Bonus Not Required)



#### Jones v. Bevier

- Lessor executed and delivered to the lessee an oil and gas lease, which lessee recorded. The lessor never received the payment of a bonus.
- Held: The lease was supported by nonmonetary consideration in the form of an affirmative drilling obligation, which was sufficient to overcome the claim by lessor that there was a lack of consideration.

### **DELIVERY**

#### **Requirements for Delivery**:



- 1. <u>Surrender of Control</u>. Surrender of possession (either actual or constructive) of the conveyance instrument to the grantee/lessee
- 2. <u>Intent for Instrument to be Effective</u>. Grantor must intend for the conveyance instrument to take effect immediately
- Whether delivery has occurred is a question of fact
- What constitutes delivery is a question of law
