### STATISTICS TO DATE

- October Term 2016
  - 62 merits decisions in argued cases
  - Decisions divided 5-3 or 5-4: 9 (15%)
  - Unanimous in judgment: 31 cases
  - Unanimous in opinion: 21 cases
- Number of 5-4 opinions (historical)
  - 2015: 4 (5%)
  - 2014: 19 (26%)
  - 2013: 10 (14%)
  - 2012: 23 (29%)

Historical data from Scotusblog

- October Term 2017 (as of June 15)
  - 63 argued cases
  - 44 opinions issued in argued cases
  - Decisions divided 5-4 or 5-3: 9
  - Unanimous: 21



## JUSTICE NEIL GORSUCH - FIRST FULL TERM (AS OF JUNE 15)

- · Five majority opinions to date
  - Texas v. N.M. (unanimous); Upper Skagit (7-2); Epic Systems (5-4); SAS Institute (5-4);
     Murphy v. Smith (5-4)
- Percentage voting agreement (from Scotusblog, as of June 11): JGR (84%), AMK (84%), CT (79%); SAA (76%); EK (67%); SGB (63%), RBG (61%), SS (61%)
- Dissents: Artis v. DC (5-4); Wilson v. Sellers (6-3); Oil States (7-2); Sveen (8-1)
- Notable vote alignments: Dimaya; Oil States; Hughes
- By comparison:
  - SS OT'09: 8 majority opinions (four unanimous, one 8-1, two 7-2, one 6-3); 3 concurrences, 4 dissents
  - EK OT'10: 7 majority opinions (three unanimous, two 8-1, two 7-2); 0 concurrences, 3 dissents
