- Service as a municipal judge.

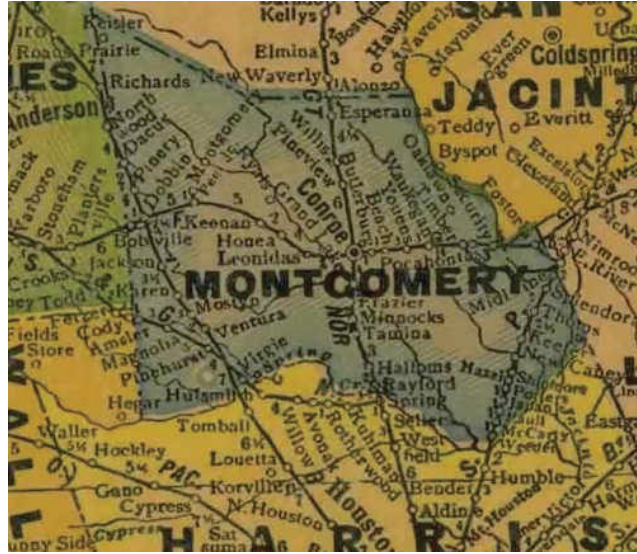

## Motive

---



- Local leaders wanted to pass a road bond measure that provided for roadway improvements throughout the county.
- Previous issued had failed
- Previous measure had been opposed by local “tea party” activists
- Some members of the Commissioners Court were motivated to craft a road bond measure that would not draw objections from these local activists

## Actus Reus

---

- The County Judge and two County Commissioners, working with a local political consultant, negotiated the parameters of a new road bond measure with local “tea party” activists.
- Emails, project lists, and draft resolutions were exchanged between the various stakeholders.
- Ultimately, a “Memorandum of Understanding” was prepared that memorialized the agreement, including the contents of the bond proposal and an agreement that the activists would support the measure.

## Government Code § 551.143

---

- At the time, Government Code § 551.143 was entitled “Conspiracy to Circumvent Chapter”
- It was an offense for a member of a governmental body to knowingly conspire “to circumvent this chapter by meeting in numbers less than a quorum for the purpose of secret deliberations in violation of this chapter.”
- Offense was a misdemeanor punishable by \$500 and six months in the county jail.
