

UNIVERSITY OF THE INCARNATE WORD v. VALERIE REDUS, ET AL.; from Bexar County; 4th Court of Appeals District (04-15-00120-CV, 580 SW3d 184, 03-07-18)

The Court affirms the court of appeals' judgment. 18-0351

Justice Bland delivered the opinion of the Court 12, in which Justice Green, Justice Guzman, Justice Lehrmann, Justice Devine, Justice Blacklock, and Justice Busby joined.

Chief Justice Hecht delivered a dissenting opinion .


