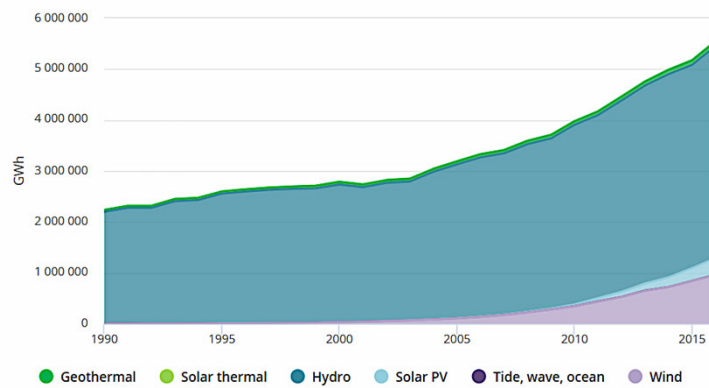

### Brazil convicts Odebrecht Group for slavery- like practices in Angola

RIO DE JANEIRO, Sept 1 (Reuters) - A Brazilian labor court convicted units of Brazil's Odebrecht Group of holding workers in conditions akin to slavery at an ethanol refinery construction project in Angola, Brazilian prosecutors said in a statement on Tuesday.

Judge Carlos Alberto Frigieri of the 2nd Part of the Labor Court of Araraquara, Brazil, ordered Odebrecht to pay 50 million reais (\$13 million) in damages.
