- “A very different Supreme Court will meet in two weeks to grapple with the potential of 4-4 splits and a caseload that includes no less than the future of the Affordable Care Act and possibly the presidential election.”

Statistics to Date (as of June 7)

- October Term 2019
 - 55 merits decisions in argued cases
 - 5-4 decisions in argued cases: 12 (22%)
 - (In addition, two 5-4 per curiams without argument)
 - Unanimous: 19 cases (35%)
- Number of 5-4 opinions (historical)
 - 2018: 21 (29%)
 - 2017: 19 (26%)
 - 2016: 7 (10%)
 - 2015: 4 (5%)
 - 2014: 19 (26%)
 - 2013: 10 (14%)

Historical data from Scotusblog

- October Term 2020 (as of June 7)
 - 58 argued cases*
 - 35 opinions issued in argued cases
 - Decisions divided 5-4 or 5-3: 3 (8%)
 - In addition, one 5-4 per curiam without argument
 - Unanimous (in judgment): 21 (60%)

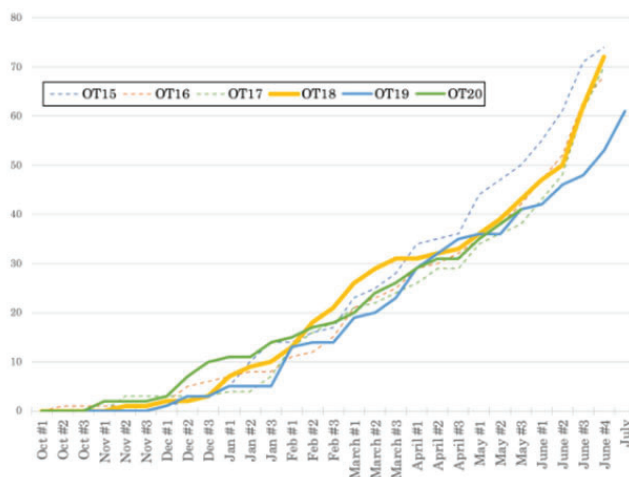

As of June 4, major cases awaiting decision (argued):

- *Fulton v. City of Philadelphia* (Nov.)
- *California v. Texas* (Nov.)
- *Brnovich v. Dem. Nat'l Committee* (Feb.)

Justice Amy Coney Barrett – First Term (as of June 7)

- Three majority opinions to date
 - *FWS v. Sierra Club* (7-2); *Fla v. Ga.* (9-0); *Van Buren* (6-3)
- Percentage voting agreement in full, part, or judgment (from Scotusblog, as of June 4): NMG (100%); CT (97%); SAA (93%); BK (93%); JGR (79%); EK (76%); SGB (72%); SS (66%).
- No authored dissents
- By comparison:
 - BK OT'18: 7 majority opinions (three unanimous, one 7-2, one 6-3, two 5-4); 4 concurrences; 3 dissents
 - NG OT'17: 7 majority opinions (one unanimous, one 7-2, five 5-4); 4 concurrences; 6 dissents
 - EK OT'10: 7 majority opinions (three unanimous, two 8-1, two 7-2); 0 concurrences, 3 dissents
