## THEN Trade Secrets & Patents

- **Trade Secrets**

- “... information, including a **formula, pattern, compilation, program, device, method, technique, or process**, that (i) **derives independent economic value**, actual or potential, **from not being generally known to or readily ascertainable through appropriate means** by other persons who might obtain economic value from its disclosure or use; and (ii) is the **subject of efforts that are reasonable under the circumstances to maintain its secrecy.**”  
*Uniform Trade Secrets Acts (all states except NY and NC)*

- **Patents**

- **Right to exclude** others, for a time, from making, using, selling, offering for sale or importing the patented invention. **Complex laws surrounding licensing and ability to enforce.** Based on the U.S. Constitution and laws promulgated through various acts passed by Congress.

## THEN Copyrights & Trademarks

- **Copyright**

- An **intangible interest in an original work of authorship**. **Owned by the “author” of the work and automatically protected upon creation.** Based on the U.S. Constitution and laws promulgated through various acts passed by Congress.

- **Trademarks**

- A word or a logo used to **identify the source of goods**. Similar protections include “service marks”, “trade names” and “trade dress”. The underlying rights in and to a trade name, a trademark, a service mark, or trade dress are **acquired through actual use in the marketplace.**
