# Texas Law Supreme Court Clinic

## • Sampling of Recent cases

- *Ramirez v. Collier* (8-1 win March 24, 2022)
  - Co-counsel for petitioner on the merits; death-row/religious liberty
- *Elhady v. Bradley* (filed May 25, 2022)
  - Co-counsel for petitioner, cert. stage; *Bivens*/interlocutory jurisdiction
- *McCall v. United States* (cert. denied May 2, 2022)
  - Co-counsel for petitioner, cert stage; imprisonment based on acquitted conduct
- *Becerra v. Gresham* (dismissed as moot April 18, 2022)
  - Counsel for Amici Texas MLPs at the merits stage; Medicaid work requirements
- Mooted 4 Advocates for OT21 Arguments
