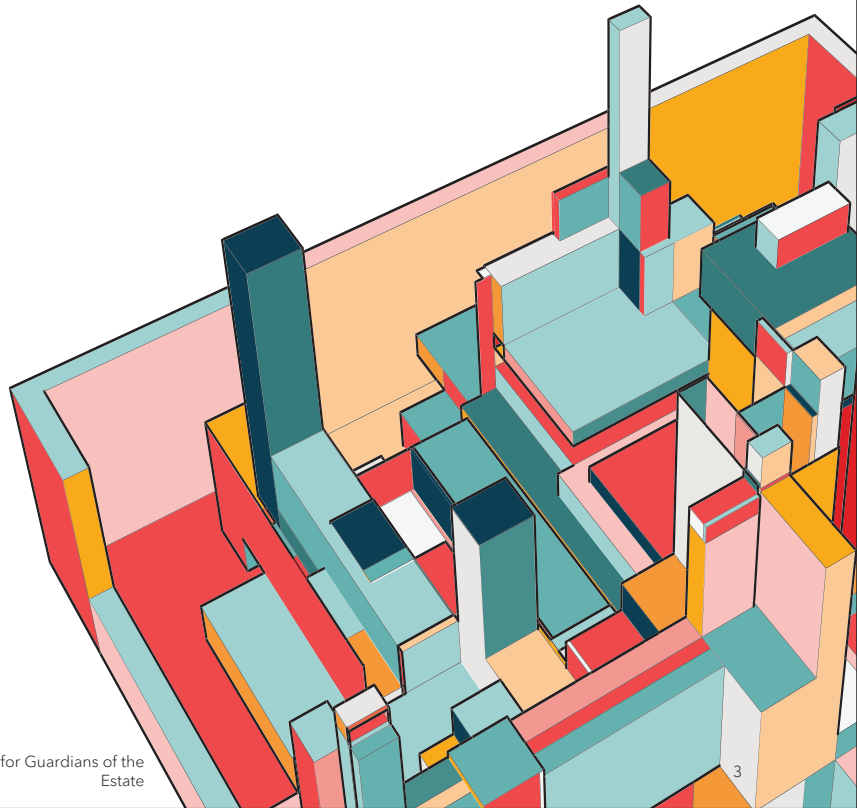

# GUARDIAN OF THE ESTATE – DEFINED

- In Texas, there are two principal kinds of guardians - a guardian of the person and a guardian of the estate.
- Though a person may serve in both roles and if appointed in both, has all rights and powers and shall perform the duties of both guardian of the person and estate , a guardian of the estate is a distinct fiduciary relationship with applicable powers and duties.
