3 MS. CHAIKIN: I was so close. For the record, Your  
4 Honor, Rebecca Chaikin of Jackson Walker LLP, proposed  
5 co-counsel to the debtors. And I'm here just to take up the  
6 motion at Docket Number 19 which is speaking on a final basis,  
7 the approval of the form notice of commencement. That's  
8 Exhibit 1 to the proposed order and we do actually have it  
9 revised at Docket 58. We actually found yet another thing to  
10 revise. The version that will be served will have that updated  
11 notice of commencement but will also correct the time for the  
12 341 meeting.

13 THE COURT: Okay.

14 MS. CHAIKIN: We're also seeking, on a final basis,  
15 authorization to serve that notice on the creditor matrix as  
16 well as authorization to redact personal identifying  
17 information, specifically individuals' home addresses and in  
18 some cases, their names as well, and redact that information  
19 from publicly filed versions of the creditor matrix, the  
20 schedules and statements, and other documents such as  
21 affidavits of service and fee applications.

22 As set forth in Paragraph 1 of the proposed order,  
23 the debtors are proposing to the Court, the United States  
24 Trustee, and counsel to the committee, once it's appointed,  
25 will automatically receive unredacted versions of any of those
