- **8,295 Bills Filed**
  - 5,388 House Bills
  - 206 House Joint Resolutions (Constitutional Amendments)
  - 2,610 Senate Bills
  - 91 Senate Joint Resolutions
- **Upcoming Deadlines:**
  - May 8th: Deadline for H.B.s and H.J.R.s must be reported from committees
  - May 12th: Last Day for House to consider 3<sup>rd</sup> readings on H.B.s and H.J.R.s

## Super Preemption

- **Field Preemption: H.B. 2127 (Burrows) and S.B. 814 (Creighton)**
  - Preemption of city and county regulation in a field occupied by the following codes (unless explicitly authorized):
    - Agriculture
    - Occupations
    - Labor
    - Finance
    - Natural Resources
    - Property
    - Business and Commerce
  - Passed House 4/19 (92Y/55N); S.B. 814 heard in Senate Business and Commerce.

# Ag Preemption

---

## **Chickens, rabbits, fowl: H.B. 92 & H.J.R. 9 (Landgraf)**

- Cities and POAs cannot prohibit: food production – veggies, rabbits, and fowl; solar or wind-powered energy device; underground shelters
- H.B. 92 Passed the House on 4/18. H.J.R. reported from House Agriculture & Livestock 3/22.

## **Agricultural Operation Regulation Limitation:**

### **H.B. 1750 (Burns) / H.J.R. 126 and S.B. 1421 (Perry) and H.B. 2308 (Ashby)**

- Bills limit city regulation of agricultural operations within the city limits.
- Not companions. Not identical.
- H.B. 1750 passed House 4/11, referred to Senate Water, Ag, and Rural Affairs 4/18
- S.B. 1421 passed the Senate 4/3, referred to House Ag and Livestock 4/17
- H.B. 2308 passed the House 4/11

## **Weedy Lot Ordinances: H.B. 1389 (Guillen)**

- Weedy lot (tall vegetation) ordinances don't apply to agricultural operations.
- Passed House 4/14.

# Annexation

---

## **Annexation of Roadways: H.B. 586 (E. Thompson)**

- Allows city to annex a right of way to create contiguity with an ETJ property requesting annexation.
- Set on House Local Calendar 4/20

## **Consent annexation across a railroad track:**

### **H.B. 2956 (Shine)**

- Voted from House Land and Resource Committee 4/18.
