## 18.001 & Paid vs. Incurred Background

- How do you prove up or challenge medical expenses?

Recovery of medical expenses in car crash cases is limited to:

- Amounts actually paid or incurred,
- that are reasonable, and
- necessary

### "Paid or Incurred"

- Paid or Incurred Statute:  
Tex. Civ. Prac. & Rem. Code § 41.0105
- Provides: "In addition to any other limitation under law, recovery of medical or health care expenses incurred is limited to the amount actually paid or incurred by or on behalf of the claimant."
- Limits both evidence & recovery of medical expenses  
*Haygood v. Escabedo*, 356 S.W.3d 390 (Tex. 2011)
