## WHAT IS THE TEXAS BUSINESS COURT?

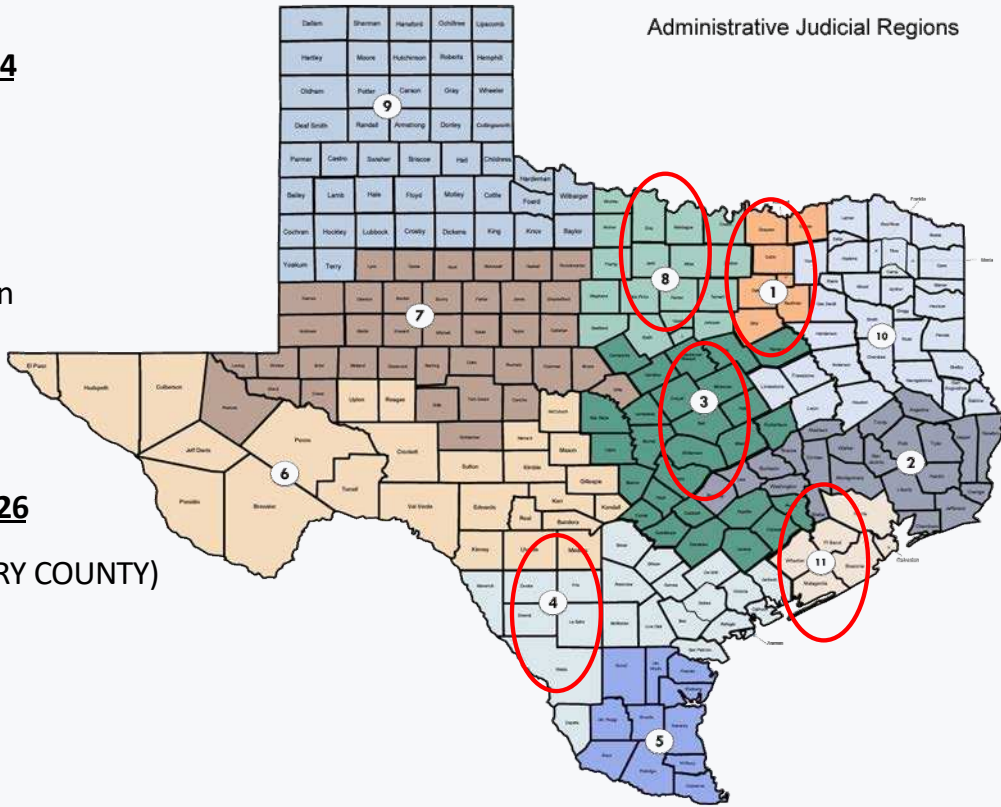
- Statutory court created effective Sept. 1, 2024
- HB 19 – signed into law in June 2023
- Chapter 25A of the Texas Government Code
- Texas Rules of Civil Procedure 352-360
- Limited subject matter jurisdiction
- One (1) Court with eleven (11) divisions
- Appeals to the newly created 15<sup>th</sup> COA in Austin
